If requesting a water sewer tap I understand that the cost of each tap must be paid upfront pursuant to the schedule of fees. I also understand that any costs 125% above the tap fee is the responsibility of the applicant and must be paid in full before service is allowed to come online. The Town of Pilot Mountain Public Works Department reserves the right to use a private contractor of choice if it so chooses. (§ 51.08 (E) (1) Water and Sewer Tap Fees)

**Meters will be read and bills will be sent out on the 1<sup>st</sup> of every other month. The payment due date will be the 15<sup>th</sup> of the billing month. After the 15<sup>th</sup> there will be a late penalty of 10% added to the bill.**

**The Water Department will not send out a second notice. If payment is not received by the 25<sup>th</sup> of the month, disconnection will be scheduled. There will be an automatic \$40.00 re-connection fee added to the account. Any past due balance plus the re-connection fee has to be paid in full before service is restored.**
